PURPOSE

The Common Agreement and Participant/Subparticipant Terms of Participation (ToP) incorporate by reference the Standard Operating Procedures (SOPs). The SOPs contain important details that Qualified Health Information Networks[™] (QHINs[™]), Participants, and Subparticipants should understand when they engage in Trusted Exchange Framework and Common AgreementSM (TEFCASM) Exchange activities. This resource is intended to help QHINs, Participants, and Subparticipants understand which SOPs are relevant to which sections of the applicable Framework Agreements. If a section of a Framework Agreement references "an applicable SOP," the section number may be included in the table below along with the applicable SOP(s). Since the section numbers are different in the Common Agreement and the ToP, there is a column for each in the chart below. If there is no section number in the ToP column, then that SOP is only relevant for QHINs and not Participants and Subparticipants.

Please note that while we strive to maintain accuracy in this resource, it is provided for educational purposes only. This resource should not be solely relied upon by QHINs, Participants, or Subparticipants.
