

HHS Secretary Xavier Becerra:


- "Each and every one of us recognizes that this is one of the main ways, long term, that we're going to bring down the cost of health care...."
- "This is going to benefit patients. It's going to support providers. It's going to be a boon in the end of the day for health care companies. But most importantly for everyone who has some connection in the healthcare system to health and safety, this takes us to the next level."
- Dr. Arati Prabhakar, Director of the White House Office of Science and Technology Policy and the President's Science Advisor, spoke about the possibilities created by TEFCA, including for improving health outcomes across the country.
- CMS Principal Deputy Administrator and COO Jonathan Blum pledged to work with ONC hand-inhand and pledged to use CMS tools to help support TEFCA.
- CDC Director Dr. Rochelle Walensky said, "We have to have a nationwide approach to public health interoperability."
- Veterans Administration Under Secretary for Health Dr. Shereef Elnahal spoke to the potential of TEFCA to improve care for veterans and improve the VA's ability to access data in support of its public health mission.

Information Blocking Exceptions – TEFCA Manner Exception

- New Exception for Actors and Requestors Capable of Exchange via TEFCA
 - The HTI-1 final rule establishes a "TEFCA Manner" Exception that applies where an actor and requestor are both part of TEFCA. Where the exception is met, an actor's practice of fulfilling certain requests for access, exchange, or use of EHI only via TEFCA will not be considered information blocking. The finalized exception applies only where:
 - · the actor and requestor are both part of TEFCA;
 - access, exchange, or use of the requested EHI can be supported via TEFCA for both the actor and requestor;
 - the request for access, exchange or use is not via API standards adopted under the ONC Health IT Certification Program;
 - any fees charged and any licensing of interoperability elements by the actor in relation to fulfilling the request via TEFCA satisfy, respectively, the Fees Exception (§ 171.302) and Licensing Exception (§ 171.303).



QHIN Application and Onboarding & Designation



Support of FHIR and Updated Roadmap





<u>FHIR® Roadmap for TEFCA</u> <u>Exchange Version 2</u> (sequoiaproject.org) • **Stage 1**: FHIR Content Support – Included as part of the initial launch of TEFCA. – QHIN-brokered IHE exchange of FHIR payloads between QHINs available.

• **Stage 2**: QHIN-Facilitated FHIR Exchange – QHIN support for facilitated FHIR API exchange required. – Participant and Subparticipant exchange via FHIR APIs available.

• **Stage 3:** QHIN-to-QHIN FHIR Exchange – Support for exchange between QHINs via FHIR APIs.

• **Stage 4:** End-to-End FHIR Exchange – Support for QHIN-brokered FHIR Exchange between Participants and Subparticipants.

ONC TEFCA RECOGNIZED COORDINATING ENTITY



The 21st Century Cures Act, signed by President Obama in 2016, calls on the Office of the National Coordinator for Health Information Technology (ONC) to "develop or support a trusted exchange framework, including a common agreement among health information networks nationally." The Sequoia Project serves as the ONC TEFCA Recognized Coordinating Entity[®] (RCESM) under a contract with ONC.

The overall goal for the Trusted Exchange Framework and Common AgreementSM (TEFCA SM) is to establish a universal floor for interoperability across the country. The Common Agreement will establish the infrastructure model and governing approach for users in different networks to securely share information with each other—all under commonly agreed-to expectations and rules and regardless of which network they happen to be in.

Nationwide sharing of health information is now possible under the Trusted Exchange Framework and Common AgreementSM (TEFCASM). The federally endorsed framework provides access to clinical data when and where it is needed for informed decisions, efficient care, and better outcomes.

In order to assist providers, payers, health information networks, public health agencies, app developers, and others that want to participate in TEFCA exchange choose the best QHIN, health information network, or other technology partner for connecting, the RCE has assembled a list of important questions to ask potential QHIN vendors or intermediary connectors.

Individuals can access their health information via TEFCA

Almost everyone needs to access their own health information—or that of a loved one—over time. The Trusted Exchange Framework and Common AgreementSM (TEFCASM) will make it easier for an individual's health information to be appropriately and securely shared online.

TEFCA will reduce the burden many patients experience as they navigate the health care system and seek to be sure that they, their doctors, and their caregivers have the right information at the right time.



You may have heard that TEFCA is now live

This means that the Trusted Exchange Framework and Common AgreementSM for sharing health information is operational and exchange is happening every minute. TEFCASM supports new and familiar exchange purposes, enabling a multitude of use cases and driving innovation.

TEFCA provides an efficient vehicle to send, receive, and query for standardized electronic health information from a broad array of participants across the nation.


TEFCA AND FHIR

HL7 FHIR is the latest addition to TEFCA Exchange

The draft Common Agreement (CA) v2.0 and draft Qualified Health Information NetworkTM (QHINTM) Technical Framework (QTF) V2.0 enable use of FHIR Release 4 for all use cases. Updated implementation Standard Operating Procedures (SOPs) will also specify how to use FHIR for specific uses.

Once these documents are finalized, Participants and Subparticipants will be able to use Facilitated FHIR to exchange data if they want to. Facilitated FHIR is designed to allow organizations to conduct transactions directly with other participants in TEFCA exchange without having a prior connection in place. It is facilitated by usage of the RCETM Directory Service for scalable endpoint discovery, the Common Agreement for consistent policy requirements, and the QTF and relevant SOPs for TEFCA-specific technical requirements.


While the initial discovery of where a patient's data resides will be done through a query to their QHIN, TEFCA exchange can be done directly with FHIR-enabled organizations that have listed a FHIR endpoint in the RCE Directory Service. This will allow organizations with FHIR capabilities to do specific queries targeted to the data they need in support of the TEFCA use cases defined.
