

## QHIN Application and Onboarding & Designation





### **TEFCA** Components



## Exchange Under TEFCA





**ONC** defines overall policy and certain governance requirements

**RCE** provides oversight and governing approach for QHINs

**QHINs** connect directly to each other to facilitate nationwide interoperability

Each QHIN connects Participants, which connect Subparticipants

# Participants and Subparticipants connect to each other through TEFCA Exchange

- Participants contract directly with a QHIN and may choose to also provide connectivity to others (Subparticipants), creating an expanded network of networks
- Participants and Subparticipants sign the same Terms of Participation and can generally participate in TEFCA Exchange in the same manner





### **Framework Agreements and TEFCA connections**

### **Common Agreement**

Each QHIN voluntarily enters into the same contractual agreement with the RCE by signing the Common Agreement

#### **Participant/Subparticipant Terms of Participation**

All Participants and Subparticipants voluntarily agree to the Terms of Participation without modification as part of their agreements with their TEFCA connector


#### **TEFCA** connector

A QHIN, Participant, or Subparticipant that offers services to connect into TEFCA exchange

#### **TEFCA** connected entity

A QHIN, Participant, or Subparticipant that has signed a Framework Agreement

#### Entities may connect into exchange at any level







### What is an SOP?

- An SOP is a written procedure or other provision that is incorporated by reference into the Framework Agreements to provide detailed information or requirements related to TEFCA Exchange
- SOPs address, among other things, governance, privacy and security requirements, RCE directory services, and QHIN application and designation
- Each SOP identifies the parties to which it applies (QHINs, Participants, Subparticipants)

# What is the Exchange Purposes (XPs) SOP?

The XPs SOP details specifications relevant to when and how information can be requested or shared through TEFCA Exchange

# What is an Exchange Purpose (XP) Implementation SOP?

XP Implementation SOPs provide additional details for specific use cases, as needed

### Why SOPs?

- SOPs create the flexibility for TEFCA to evolve and expand over time
- SOPs will be created and modified as needed and finalized through a defined change management process

### Transition from Version 1.1 to Version 2.0



- TEFCA is currently live on Common Agreement Version 1.1 for QHINs
- Applicable Flow-Down provisions are applied to Participants and Subparticipants
- There is a transition period to allow for adoption of the new Framework Agreements by those who are already live

   60 days for the Common Agreement
  - $_{\odot}$  180 days for the Terms of Participation
- During the transition, all TEFCA connected entities can engage in TEFCA Exchange for approved Exchange Purposes
- QHINs are responsible for adding new TEFCA connected entities to the RCE Directory as they sign the Terms of Participation

- TEFCA RECOGNIZED COORDINATING ENTITY
- 1. Requirements for registration, authentication, and authorization of FHIR clients MUST follow these requirements:
  - a. Prior to January 1, 2026:
    - i. All FHIR Adopters MAY follow the requirements of HL7 FAST Security IG 1.0.0 (SSRAA) Registration process
      - 1. Manual registration requests MUST be resolved within 5 days where sufficient information has been provided. Information requirements MUST NOT exceed those of SSRAA and this SOP.
    - ii. All FHIR adopters MUST use one of the following:
      - 1. SSRAA Authentication and Authorization sections
      - 2. SMART Release 1.0.0; or
      - 3. Another authentication and authorization framework that adheres to QTF requirements and based on out-of-band agreements between exchange partners.
  - **b. Beginning January 1, 2026**, all FHIR Adopters MUST follow SSRAA for registration, authentication and authorization



### Purpose

- A FHIR Implementation Advisory Group will be established to collect and document learnings and progress towards adoption of a network-wide approach to Facilitated FHIR, including assessing adoption and implementation of the HL7 Security for Scalable Registration, Authentication, and Authorization (HL7 SSRAA) FHIR Implementation Guide (IG).
- The FHIR Implementation Advisory Group will provide regular updates to the TEFCA Transitional Council or the Governing Council (as applicable) on progress, and informed by that progress
- The FHIR Implementation Advisory Group will have the authority to recommend changes to the dates in the FHIR Security Roadmap detailed in Section 4.4 of the Facilitated FHIR SOP and/or conformance statements throughout the SOP for approval by ONC and the RCE.





# Treatment

### **Treatment Implementation SOP**



- "Treatment" is an Exchange Purpose (XP) under Common Agreement Version 1.1
- TEFCA currently allows Health Care Providers to send Queries for Treatment purposes
- Currently, there is no Treatment Implementation SOP, but we have received feedback asking for more granularity in the Treatment XP
- A feedback form was circulated to PTAG members on use cases that are believed to meet the definition of "Health Care Providers" and "Treatment" and those that do not

"Health Care Provider" is defined in the Common Agreement Version 2.0 as meeting the definition of such term in either 45 CFR § 171.102 or in the HIPAA Rules at 45 CFR § 160.103.

"Treatment" has the meaning assigned to such term at 45 CFR § 164.501, which is "the provision, coordination, or management of health care and related services by one or more health care providers, including the coordination or management of health care by a health care provider with a third party; consultation between health care providers relating to a patient; or the referral of a patient for health care from one health care provider to another."


# Governance





### **Governing Approach**

- The Common Agreement establishes a Governing Council that:
  - » Reviews amendments to the Common Agreement, QTF, and SOPs
  - » Serves as a resource to the RCE and a forum for discussion
  - » Provides oversight for resolution of disputes
- A Transitional Council serves during TEFCA's first year
- ONC oversees the work of the RCE, which has specific obligations to follow the governance procedures set forth in the Common Agreement
- Advisory groups will be formed to provide targeted input from stakeholders





### **TEFCA Governing Council SOP**

• Provides the specifics for the composition, conduct and other issues for the Governing Council

#### Draft Governance Approach SOP

 Sets forth the formation, composition, responsibilities and duration of the Transitional Council and Governing Council

#### Advisory Group SOP

 Sets out the way in which Advisory Groups will be established and the general rules that govern the activity of an Advisory Group



**Goal:** To create one Governance SOP that governs the Governing Council, the Caucuses, and the Advisory Groups by Fall of 2024

### Phase 1 (May - July):

• Review SOPs key governance topics and draft updates (e.g., composition, duration, leadership, conduct, etc.)

### Phase 2: (July - September):

 Incorporate draft updates with current language and draft combined SOP


### Phase 3: (July - September):

 Present new Governance SOP to the PTAG, incorporate feedback, and publish new Governance SOP
